1. The employee will take seniority in the new seniority unit to which he is transferred as per extant rules applicable for mutual transfer (i.e he will retain his own seniority or take the seniority of the other in the new seniority unit to which he is posted, whichever is lower).
2. He will retain his lien in his parent Railway till such time he is finally absorbed in the new seniority unit.
3. There should not be any DAR/SPE/Vig, cases pending/contemplated against him on the date of relief.
4. He is not eligible for any privileges on transfer account such as joining time, T.A. Transfer grant,

transfer pass etc, as the transfer is ordered at his own request.

5. He should vacate the Railway quarter if any, under their occupation and hand over the Railway material, if any under their possession to their immediate supervisor.

6. He is hereby advised that in terms of Railway Board's No.E (EN)I-2006/TR/6 dated 21-04-06, no request for back tracking from the mutual exchange will be entertained under any circumstances.

7. In terms of Railway Board's letter No.E (NG)I-2017/TR/24 dated .09.05.18, Mutual Transfer cases where NOC has been given by both the Railways/Units i.e. accepting and relieving, both the employees should be spared immediately within one week, without either unit waiting for the reliever.
